The W.K. Kellogg Foundation supports children, families, and communities as they strengthen and create conditions that propel vulnerable children to achieve success as individuals and as contributors to the larger community and society.

Most grants are awarded in the United States (with emphasis on Michigan, Mississippi, New Mexico, and New Orleans, LA) as well as Mexico and Haiti.

The Foundation's interests include the following:

## **Thriving Children**

The Foundation believes children are more likely to thrive when they have a healthy start and quality learning experiences.

In this priority area, the Foundation is interested in:

- improving access to high-quality early childhood education;
- supporting healthy birth outcomes, quality maternal and infant healthcare, and children's early development;
- increasing breastfeeding rates;
- expanding access to oral healthcare;

- increasing access to fresh, local, healthy food and improving nutrition for children and families in early child care settings; and,
- promoting community voices and leveraging strategic partnerships and policy and systems changes
  to help families and civic leaders play an active role in making children's development and wellbeing central to their decision making.

# **Working Families**

The Foundation believes children are more likely to thrive when their families are economically secure.

In this priority area, the Foundation is interested in:

- widening pathways to stable high-quality jobs and more equitable employment opportunities;
- expanding support for tribal-, minority-, and women-owned business enterprises;
- accelerating small business growth;
- informing policies and change systems to create greater economic stability for families and communities; and,
- supporting local efforts in Mexico and Haiti that improve and strengthen production, product development, value chains, and microenterprise.

#### **Equitable Communities**

The Foundation believes children are more likely to thrive in vibrant and equitable communities.

In this priority area, the Foundation is interested in:

- advancing racial equity and racial healing;
- engaging communities in solving their own problems; and,
- developing leaders capable of guiding change.

#### **Restrictions Details:**

### We Got Us Fund

This fund was formed in response to rising anti-Asian violence and to address the need to assist frontline organizers. Supported organizations focus on:

- leadership development for formerly incarcerated individuals and those impacted by detention and deportation;
- cultivating culturally relevant healing;
- promoting cross-racial solidarity; and,
- protecting communities from systemic and interpersonal violence.

#### **Areas of Interest:**

Working strategically and collaboratively in philanthropic efforts that are critical to the success of our region, particularly efforts in economic mobility and youth connections.

The Foundation administers the following funding opportunities:

#### Episcopal Presbyterian Health Trust

This trust is dedicated to providing access to healthcare for underserved populations in the St. Louis area. The focus is on organizations that are looking to expand services, model new approaches to healthcare delivery, or to build collaborations.

#### **Pettus Foundation**

This foundation primarily supports nonprofit organizations in the St. Louis area. Applications are by invitation only.

The Foundation provides grants for:

- education, including early childhood education and K-12 schools, with a focus on the middle school years; and,
- workforce development, including soft skills and direct job, technical, and career training; and,
- youth development, such as preparation for the workforce, including soft skills, and preparation for life after high school, including higher education, technical school, military, or apprenticeship programs.

## **Charless Foundation**

This foundation supports organizations working with economically underserved seniors in the St. Louis region, with priority given to those in South St. Louis City. Broadly, the goal of these grants is to promote the health, welfare, and wellness of older adults. More specifically, the Foundation is interested in organizations and initiatives that

- support the needs of older adults in residential facilities;
- increase the ability of older adults to age in place;
- provide health and safety resources for older adults; and,
- provide social support to older adults.

The Charless Foundation is open to proposals for program, project, or initiative funding; general operating support or capacity building.

#### **Gateway Regional Environment Fund**

This program supports projects in the St. Louis metro area that advance community efforts to reduce the region's carbon footprint.

### Guy B. Jaffe and Judy Schwartz Jaffe Charitable Foundation

This program provides grants in the priority areas of entrepreneurship, job creation, and cultural arts. In addition, one annual IMPACT grant is made to a St. Louis-based Jewish organization that provides innovative programming to their community.

### Spirit of St. Louis Women's Fund

This program awards grants to smaller St. Louis-area nonprofits.
